## ORDINANCE NO. 2009-34

## AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING CERTAIN ROADWAYS AND STREETS WITHIN THE PHEASANT RUN DEVELOPMENT

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the "Township"), has been advised by the Township Engineer that all streets and roads located within the Pheasant Run Development ("Pheasant Run") have been constructed in accordance with the Township's Land Use Ordinances and in accordance with Resolutions of approval granted by the Barnegat Township Planning Board; and

**WHEREAS**, the streets and roads located within Pheasant Run which are to be accepted by the Township are described as follows:

Refer to attached list of streets in Pheasant Run. (A total of 17 streets are being accepted); and

**WHEREAS**, the Homeowners Association of Pheasant Run has requested that the Township accept the aforementioned streets; and

**WHEREAS**, consistent with the provisions of the Public Offering Statement (POS), the Pheasant Run Homeowners Association has voted in the affirmative to dedicate all of the streets and roads in the Township of Barnegat located within Pheasant Run; and

**WHEREAS**, the Township is permitted and authorized to accept the streets and roadways in accordance with the provisions of <u>N.J.S.A.</u> 40:67-23.7:

**NOW THEREFORE BE IT ORDAINED** the 19<sup>th</sup> day of October, 2009 by the Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey, as follows:

**SECTION 1**. The Township hereby accepts, for use by the general public, the aforementioned streets and roads located within Pheasant Run. The Township acknowledges that the streets and roads conform to the Township's specifications for public streets and roads as set

**SECTION 2**. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

**SECTION 3**. Any Ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

**SECTION 4**. This Ordinance shall take effect after second reading and publication in an official newspaper as required by law.
