**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARING CONTRACT FOR THE SUPPLY OF BELL MINE HYDRATED HIGH CALCIUM LIME TO YARDVILLE SUPPLY COMPANY**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited bids for the supply of Bell Mine Hydrated High Calcium Lime for 2009; and

1. The Township accepts the recommendations of its professional staff and awards the contract for the supply of Bell Mine Hydrated High Calcium Lime for 2009 to the sole responsible bidder, Yardville Supply Company, Inc., for and in consideration of \$42,075.00.
