RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING RELEASE OF FUNDS HELD BY THE TOWNSHIP TO THE MENK CORPORATION IN ACCORDANCE WITH THE SANITARY SEWER REIMBURSEMENT AGREEMENT AND THE WATER REIMBURSEMENT AGREEMENT

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has previously entered into agreements with the Menk Corporation ("Menk") which agreements are entitled Water Reimbursement Agreement ("Water Agreement"), as amended, and Sanitary Sewer Reimbursement Agreement ("Sewer Agreement"); and

**WHEREAS**, the Township is currently holding in escrow approximately \$388,510.60 of water reimbursement monies paid by other developers in Barnegat, as well as \$34,888.00 (principal only) and \$36,421.11 (sewer interest only) from monies paid by other developers; and

**WHEREAS**, Menk has demanded release of those funds by the Township; and

**WHEREAS**, the Township has received indications from other developers that they intend to institute suit against the Township because of what they perceive to be improper payments made by the Township to Menk in conjunction with the Water Agreement and Sewer Agreement:
