

## **RESOLUTION NUMBER 2009 - 625**

### **RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE BARNEGAT TOWNSHIP BOARD OF EDUCATION**

**WHEREAS**, the Township of Barnegat and the Barnegat Township Board of Education have various and numerous resources employed to maintain the infrastructure and related public property of the community, and

**WHEREAS**, on an informal basis, the Township of Barnegat and the Barnegat Township Board of Education have been providing assistance to each other in order to advance the public good, and

**WHEREAS**, the Township of Barnegat and the Barnegat Township Board of Education wish to formally recognize this working relationship by establishing an shared services agreement, and

**WHEREAS**, the Interlocal Services Act, N.J.S.A. 40-8A-1 et seq., encourages municipalities to combine services in order to achieve financial and operational benefits as a result of economies of scale, and

**WHEREAS**, the Interlocal Services Act provides the legal authority and required procedures to effectuate such shared services agreements, and

**WHEREAS**, the Township of Barnegat and the Barnegat Township Board of Education wish to share public resources utilized in the maintenance, upkeep, repair and improvement of public property and facilities, and

**WHEREAS**, the Township of Barnegat will be the lead agency for this shared services agreement and will maintain necessary records which reflect resources utilized under this agreement, and

**WHEREAS**, there will be no cost charged by either governmental entity as a result of this shared services agreement since it is mutually beneficial for each public entity to enter into this agreement and to share resources, and

**NOW THEREFORE, BE IT RESOLVED**, by the Governing Body of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township authorizes and directs the Mayor, Township Administrator and Township Clerk to execute any and all necessary documents needed in order to implement the intent of this resolution.
2. The Township authorizes the Township Administrator to take the required action to institute the intent of this resolution and to incorporate the desired benefits of the resolution into the daily operations of the Township.
