

RESOLUTION NO. 2009 - 626

RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING CONTINUED DISCUSSIONS WITH REPRESENTATIVES OF THE TOWNSHIP OF OCEAN, AND OTHER AREA MUNICIPALITIES, IN ORDER TO FACILITATE A SHARED SERVICES AGREEMENT

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has had informal discussions with representatives of the Township of Ocean, as well as other area municipalities, with regard to a potential Shared Services Agreement (the “Agreement”); and

WHEREAS, these discussions, initiated by the Township, would involve sharing of services by and between the municipalities for, but not limited to, Department of Public Works services; bill collections services; sharing of large and expensive equipment; joint purchasing of materials, equipment and services, etc.; and

WHEREAS, the Township believes that these discussions have been extremely beneficial, and will lead to long term agreements, as initiated by the Township, with other neighboring communities, in order best assist the Township, its taxpayers and residents:

NOW, THEREFORE, BE IT RESOLVED, this 5th day of October, 2009 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township fully supports the continued discussions with representatives of neighboring communities with the expectation of a Shared Services Agreement by and between the Township and neighboring communities concerning Department of Public Works services; bill collections services; sharing of large and expensive equipment; joint purchasing of materials, equipment and services, etc.
