**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AUTHORIZING THE TAX COLLECTOR TO REFUND
OVERPAYMENT DUE TO SUBDIVISION**

WHEREAS, an overpayment has been received by the Tax Office, for several block and lots, in the amount of \$6,669.29, and

WHEREAS, the owner had paid the estimated taxes due during the first half of the billing period, and has provided valid proof of payment made, however due to a subdivision, the taxes are now assessed over several parcels, which created an overbill on the mother lot, and those monies should therefore be refunded as follows:
