ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, CANCELLING CERTAIN FUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR VARIOUS WATER AND SEWER CAPITAL PROJECTS TOTALING \$88,369.94 AND REAPPROPRIATING SUCH FUNDED APPROPRIATION BALANCES FOR VARIOUS WATER AND SEWER CAPITAL IMPROVEMENTAS AND TO REAPPROPRIATE THE SUM OF \$88,369.94 TO PAY THE COST THEREFORE

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, (not less than two-thirds of all members thereof affirmatively concurring), pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey as amended and supplemented as follows:

SECTION 1. The following funded appropriations remaining as a balance in the bond ordinances heretofore adopted by the Township of Barnegat, County of Ocean, State of New Jersey are hereby cancelled:

SECTION 2. The aggregate sum of \$88,369.94 is hereby reappropriated from the bond ordinances referred to in Section 1 for the following purposes:

<u>Purchase of Meters</u>: Related to the acquisition of various types and sizes of water meters.

Amount of Appropriation - \$16,869.94

Vehicle to be equipped with all the necessary accessories and equipment required by the Utility Department's daily operations.

Amount of Appropriation - \$25,000.00

<u>Purchase of Well No. 8</u>: Any and all costs associated with the decommissioning of Well No. 8 in accordance with the NJDEP rulses and regulations. Costs include the preparation of contract documents for project bids, review and the finalizing of contract documents and payment vouchers. Engineering services will include construction administration and inspection services necessary to insure that the contractor is performing all the work in full accordance with the contract documents and NJDEP requirements.

Appropriation - \$46,500.00

SECTION 3. The period of usefulness of said purpose, within the limitation of the Local Bond Law and according to the reasonable life thereof computed from the date of said bonds authorized by this ordinance, is not less than five (5) years.

SECTION 4. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the

SECTION 5. The improvements authorized are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the improvements authorized hereby has been or shall be specially assessed on any property benefited thereby.

SECTION 6. This ordinance shall take effect twenty (20) days following the first publication thereof after final passage, as provided by the Local Bond Law.
