ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, OFFERING FOR SALE REAL PROPERTY AND ALL IMPROVEMENTS THEREON LOCATED AT BLOCK 250, LOT 23, A/K/A 686 EAST BAY AVENUE, BARNEGAT, NEW JERSEY

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the "Township") is the owner of real property and all improvements thereon located at Block 250, Lot 23, a/k/a 686 East Bay Avenue, Barnegat, New Jersey, upon which the emergency management building is located (the "property"); and

SECTION 3. The minimum price for the public sale will be \$350,000.00, cash proceeds.

SECTION 4. At the public sale five (5%) percent of the total price must be provided by cash or check to the Township, which sum shall be held by the Township in trust pending closing and passing of title.

SECTION 5. The property is being sold by the Township in its "as is" condition. The Township makes no representations as to the structural integrity, condition of the property, or future use of the property.

SECTION 9. The Township makes no representations with regard to the condition or quality of the property, but agrees that the Township shall convey clear and marketable title to the successful bidder.
