ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 66 ENTITLED "STREETS AND SIDEWALKS", IN PARTICULAR AMENDING ORDINANCE 2007-22, OF THE CODE OF THE TOWNSHIP OF BARNEGAT

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, that Chapter 66 of the Code of the Township of Barnegat, entitled "Streets and Sidewalks" is hereby amended and supplemented, as follows:

SECTION I. Article IV entitled "Regulations for Street Openings" shall be supplement by the addition of the following:

NEW SECTION

<u>G.</u> In the event that the Township does not have in hand the inspection fee of \$250.00, the inspection fee shall be deducted from the cash or surety bond held by the Township in accordance with Article IV(C).

SECTION II. <u>Severability.</u> The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

SECTION III. <u>Repealer.</u> Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.
