ORDINANCE NUMBER 2009-21

ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY CANCELING CERTAIN FUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR VARIOUS GENERAL CAPITAL PROJECTS TOTALLING \$631,126.91 AND REAPPROPRIATING SUCH FUNDED APPROPRIATION BALANCES FOR VARIOUS GENERAL CAPITAL IMPROVMENTS AND TO REAPPROPRIATE THE SUM OF \$631,126.91 TO PAY COST THEREFORE

BE IT ORDAINED by the Township Committee of Barnegat, County of Ocean, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

SECTION 1. The following funded appropriations remaining as a balance in the bond ordinances heretofore adopted by the Township of Barnegat, County of Ocean, State of New Jersey ("Township") are hereby cancelled:

SECTION 2. The aggregate sum of \$631,126.91 is hereby reappropriated from the bond ordinances referred to in Section 1 for the following purposes:

A. Township Wide Paving Program

Any and all cost associated with the comprehensive reconstruction and rehabilitation of township roads and streets. Work includes items such as roadway design and construction document preparation, construction management and administration, along with actual construction work necessary for the proper reconstruction and rehabilitation of township roads, streets and supporting infrastructure like drainage and sidewalks. Copies of all plans, specifications and

construction documents associated with this work will be maintained on file in the office of the Township Clerk.

Amount of Appropriation -- \$404,126.91

B. Police Communication Equipment

Any and all cost associated with the purchase and installation of required furniture, equipment and other items necessary to properly accommodate planned modernization of police communication system. Furthermore, includes cost associated with the relocation of existing police communication system to new larger space.

Amount of Appropriation -- \$72,000.00

C. Property Acquisition and Easements

Any and all cost needed to acquire actual property or to secure property easements necessary to complete planned township roadway improvement work. Cost includes legal, engineering services along with purchasing cost required to properly execute agreements for land or easement acquisition.

Amount of Appropriation -- \$65,000.00

D. Fire Equipment

Cost associated with the purchase of fire related equipment needed for Barnegat Volunteer Fire Company and Pinewood Estates Volunteer Fire Company. Includes purchase of fire fighting personal protection clothing such as turn out gear, self contained breathing apparatus (SCBA), protection alert safety systems (PASS) devices, communication equipment along with various fire fighting items such as hoses, nozzles and a thermal camera.

Amount of Appropriation -- \$60,000.00

E. Facility Improvement Work -Emergency Power

Any and all cost associated with enhancing emergency power capabilities of various facilities including Township Hall and Pinewood Estates Volunteer Fire Station. Includes work required to properly install and connect emergency

generators or emergency back up power to these critical facilities in accordance with state Uniform Construction Code.

Amount of Appropriation -- \$15,000.00

F. Improvement Work -Municipal Dock

Cost of work necessary to make improvements to municipal dock area, including landscaping materials, signage and acquisition of solid waste receptacles and benches.

Amount of Appropriations -- \$15,000.00

SECTION 3. The period of usefulness of said purpose, within the limitation of the Local Bond Law and according to the reasonable life thereof computed from the date of said bonds authorized by this ordinance, is not less than five (5) years.

SECTION 4. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the clerk and available for inspection.


SECTION 5. The improvements authorized are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

SECTION 6. All ordinances or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 7. This ordinance shall take effect twenty (20) days after the first publication thereof after final passage, as provided by the Local Bond Law.

NOTICE IS HEREBY GIVEN that the foregoing ordinance was introduced on first reading at a regular meeting of the Barnegat Township Committee held on the 15th day of June, 2009, and will be considered for second reading and final adoption at a regular meeting of said Committee to be held on the 20th day of July, 2009, at 900 West Bay Avenue, Barnegat, New Jersey at which time and place any person wishing to be heard on the subject shall be given an opportunity to be so heard.
