ORDINANCE 2009-22

ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, CANCELLING CERTAIN FUNDED AND UNFUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR VARIOUS WATER AND SEWER CAPITAL PROJECTS TOTALING \$244,800.00 AND REAPPROPRIATING SUCH FUNDED AND UNFUNDED APPROPRIATION BALANCES FOR VARIOUS WATER AND SEWER CAPITAL IMPROVEMENTS AND TO REAPPROPRIATE THE SUM OF \$244,800.00 TO PAY THE COST THEREOF

Be it ordained by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

Section 1. The following funded appropriations remaining as a balance in the bond ordinances heretofore adopted by the Township of Barnegat, County of Ocean, State of New Jersey ("Township"), are hereby cancelled: Ordinance #08-16 in the amount of \$244,800.00.

Section 2. The aggregate sum of \$244,800.00 is hereby reappropriated from the bond ordinance referred to in Section 1 for the following purposes:

A. Water Main Extension - Memorial Drive and Hillside Avenue

Any and all costs associated with work required to properly install water mains on Memorial and Hillside Drive. Work includes professional services such as project design and construction document preparation, permitting, and construction administration and management, along with the cost of construction work necessary to install the water main and other related infrastructure needed to place the water main into service. Copies of related specifications and construction drawings will be on file in the office of the Township Clerk.

Amount of appropriation -- \$244,800.00

Section 3. The period of usefulness of said purpose, within the limitation of the Local Bond Law and according to the reasonable life thereof computed from the date of said bonds authorized by this ordinance, is not less than five (5) years.

Section 4. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency therewith, and the resolution

promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the clerk and available for inspection.

Section 5. The improvements authorized are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the improvements authorized hereby has been or shall be specially assessed on any property benefited thereby.

Section 6. This ordinance shall take effect twenty (20) days after the first publication thereof after final passage, as provided by the Local Bond Law.

Notice is hereby given that the foregoing ordinance was introduced on first reading at a regular meeting of the Township Committee of Barnegat Township, County of Ocean, State of New Jersey on the 15th day of June, 2009, and will be considered for second reading and final passage after public hearing at a regular meeting of the Barnegat Township Committee to be held on the 20th day of July, 2009, at 6:30 PM, 900 West Bay Avenue, Barnegat, New Jersey, at which time and place any person desiring to be heard will be given an opportunity to be so heard.
