RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING THE CONTRACT FOR THE NJDOT – TRANSPORTATION TRUST FUND PROJECT FOR ROSE HILL ROAD TO EAGLE PAVING CORPORATION

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has solicited bids for the NJDOT – Transportation Trust Fund Project for Rose Hill Road (the “project”); and
