**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AWARDING THE CONTRACT FOR THE ADMIRAL COURT,
ENSIGN AVENUE, HELM STREET AND MIZZEN DRIVE
REPAVING PROJECT TO JOHNSON BARAN CORP.**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township"), has solicited bids for the Admiral Court, Ensign Avenue, Helm Street and Mizzen Drive Repaving Project (the "project"); and

WHEREAS, the bids have been solicited by the Township in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, four (4) bids have been received in response to the bid solicitation, as follows:
