RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING WAIVER REQUEST FOR A ROAD OPENING PERMIT SUBMITTED BY MARY C. BROADWAY, FOR BLOCK 114.28, LOT 3, A/K/A 151 VILLAGE DRIVE, BARNEGAT, NEW JERSEY

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey, (hereinafter referred to as the “Township”) has received a request from Mary C. Broadway (the “applicant) for a road opening permit for a single-family home at 151 Village Drive, Barnegat, New Jersey, a/k/a Block 114.28, Lot 3 (the “property”); and
