AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT made this day of , 2010, between the County of Ocean, a body politic and corporate in law of the State of New Jersey, hereafter called the party of the first part, and Township of Barnegat, a local governmental unit of the State of New Jersey, herinafter called the party of the second part.

WHEREAS the governing body of Township of Barnegat entered into an agreement with the County of Ocean on April 7, 2010 for some type of road maintenance, road overlay, hauling of sweeping and repair of the Local Governmental Unit Roads; and

WHEREAS the said governing body of the Township of Barnegat has now requested that they be permitted to <u>increase</u> the amount of the contract.

WITNESSETH that the said parties in consideration of the premises and agreements hereafter contained, do hereby mutually agree as follows:

- 1. The Agreement between County of Ocean and the Township of Barnegat dated April 7, 2010 is hereby amended.
- 2. The governing body of the Township of Barnegat shall pay to the County Treasurer the additional sum of \$9,000.00 for anticipated expenditures for the following:
