RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACCEPTANCE AND EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF LITTLE EGG HARBOR FOR THE PROVIDING OF CONSTRUCTION CODE ENFORCEMENT SERVICES

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (“Barnegat”), and the Township of Little Egg Harbor, County of Ocean, State of New Jersey (“LEH”) have determined to take advantage of the provisions of the Shared Services and Consolidation Act, N.J.S.A. 40A:65.1 *et seq.*, by entering into an agreement to minimize the costs of providing construction code enforcement services within each municipality; and

WHEREAS, the aforesaid Shared Services and Consolidation Act does authorize local units as defined in the Act to enter into joint agreements for the provision of governmental services, including providing construction code enforcement services; and

WHEREAS, it is the desire of Barnegat and LEH to jointly provide certain governmental services, including construction code enforcement services:

NOW, THEREFORE, BE IT RESOLVED, this ____ day of _____, 2010, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts and approves the Shared Services Agreement as prepared by the Township Solicitor, a true copy of which is on file at the Office of the Township Clerk and can be reviewed by the public during normal business hours.

2. This Agreement is entered into pursuant to the provisions of N.J.S.A. 40A:65.1 *et seq.*, and shall remain in full force and effect for a period of four years, subject to the terms

of the Agreement. Sufficient funds have been appropriated and are available for this purpose in the current Township Budget.

3. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.
