RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, DECLARING A DEFAULT IN THE CONSTRUCTION OF SITE IMPROVEMENTS AND THE ASSOCIATED PERFORMANCE BOND REQUIREMENTS FOR BLUE CLAW ESTATES, BARNEGAT TOWNSHIP, NEW JERSEY

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township"), has previously granted approvals, in conjunction with the Barnegat Township Planning Board, to Home Mark Homes, Inc. (the "Developer") for construction of a residential subdivision known as "Blue Claw Estates; and

**WHEREAS**, in conjunction with the approvals, the Developer is required to install both onsite and offsite site improvements as mandated by the Barnegat Township Planning Board and other governmental agencies; and

**WHEREAS**, the construction of the site improvements is guaranteed by a performance bond issued by Kemper Casualty Insurance Company/Universal Bonding Company (collectively referred to as the "Bonding Company"); and

**WHEREAS**, numerous site deficiencies exist at the development which have been brought to the attention of the Developer and the Bonding Company; and

**WHEREAS**, both the Bonding Company and the Developer have failed to properly respond to the requirement to complete and as appropriate, correct the required site improvements; and

**NOW, THEREFORE, BE IT RESOLVED**, this day of October, 2010, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

- 1. The Township accepts the recommendations of its professional staff and hereby declares a default by the Developer, Home Mark Homes, Inc. and the Bonding Company, Kemper Casualty Insurance Company/Universal Bonding Company, because of the failure of both the Developer and the Bonding Company to properly complete the site improvements at Blue Claw Estates, Barnegat Township, New Jersey.
- 2. The Township authorizes and directs its professional staff to take any and all necessary actions, including litigation if necessary, to remedy the outstanding deficiencies which are the responsibility of both the Developer and the Bonding Company.
- 3. The Township authorizes and directs the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
