**Committeeman Lisella:** We have 120 Vendors signed up for Pirate's Day so far. It should be a real success. The Opening Ceremony will be at 9:00AM. Please come down and see it. As for my sports report, Vikings and the Saints but not until Thursday.

**Committeewoman Ryan**: The concerts have been great and I am happy to report that donations have amounted to \$1,323.98 so far. The money will be deposited to the Recreation Trust Fund and used to help fund the concerts next year. The Municipal Dock and the music are a wonderful asset to our community.

**Committeeman Morano**: We have had just a great time at the Saturday concerts at the Dock and now we have Sinatra on Sundays and soon we may have Barbra Streisand concerts. So come down and enjoy the concerts with us.

**Deputy Mayor Cirulli**: We are continuing to look into Public Works staffing and streamlining duties to best benefit our residents. Cannot speak about the Ocean County lawsuit because it is under litigation but it is progressing. We are also looking in to Oyster Creek to keep that facility news updated.

**6. Administrator's Report**: I am happy to report that two miles of sidewalks have been successfully installed in time for the first day of school. Many thanks to John Hess, Jerry Dasti and Bruce Connell for their hard work in seeing this project through. It was indeed challenging.

Our Fun-time Day Camp at the Dunfee School was a huge success. Over 170 campers participated. Many thanks to the Board of Education for their cooperation. We had the use of five or six school busses. Marianne Clemente – 565 East Bay Avenue: Asked about the budget. Also asked what the income will be for Barnegat under the LEH Shared Services agreement. Mr. Breeden said it will depend on the volume and assured Ms. Clemente that it will generate revenue. I am lucky to have Senator Connors here because I need to ask if the Township will generate a resolution in support of overturning the Governor's veto of the Women's Health Care Bill and ask him if he will support that. Senator Connors replied No and explained his position.

**Jason Bing, Superintendent of Barnegat Schools:** I am here to report that we had an extremely good first day of school and express my thanks to the Chief of Police for all the cooperation to make this first day smooth. I also wish to thank the Township Committee for their efforts in the timely completion of the sidewalks that were necessary for Safe Routes to School. It was also wonderful to have the kids be able to attend the Summer Camp. Our Friday night football starts on September 10<sup>th</sup> and we are in the midst of a solar energy initiative. We should be able to reduce our energy consumption by 50%.

**Walt Fernandez** – **31 Fifth Street**: Day on the Bay has been ongoing for five years now and it gets better each year. We have seen 1000 to 1500 people participate and enjoy this event. Many thanks to the Police Department and Officer Yates who does the kid ID program. Also the Fire Department and Quality Ambulance for their volunteerism.

Scott Nevins – 427 East Bay Avenue: He wanted to report that he was not polled to ask if the residents of Pebble Beach wanted the area to be named Pirate's Peninsula.
