## Ordinance 2011-17

## AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING ACQUISITION BY GIFT OF BLOCK 137, LOTS 1 AND 2, BARNEGAT TOWNSHIP, NEW JERSEY, FROM JOSEPHINE SANTILLO, PURSUANT TO THE PROVISIONS OF <u>N.J.S.A.</u> 40A:12-5

Be it ordained by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follow:

**WHEREAS**, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, (the "Township") has received a letter dated August 12, 2011 from Josephine Santillo, owner of vacant property known and designated as Block 137, Lots 1 and 2, Barnegat Township, New Jersey (the "Property"); and

**WHEREAS**, Josephine Santillo has offered to gift the property to the Township for no consideration; and

**WHEREAS**, The Township finds it appropriate and reasonable to accept this gift which will convey the property free and clear of any liens or encumbrances, all in accordance with the provisions of <u>N.J.S.A.</u> 40A:12-5.

**THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Ocean, State of New Jersey, this 17<sup>th</sup> day of October, 2011 as follows:

1. The Township accepts the gift, for no consideration, of vacant property know as Block 137, Lots 1 and 2, Barnegat Township, New Jersey from Josephine Santillo, with thanks on behalf of the Township.

3. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this Ordinance.

4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

6. This ordinance shall take effect after second reading and publication as required by law.
