## **ORDINANCE NO. 2011 - 03**

ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY REPEALING CHAPTER 38B OF THE TOWNSHIP CODE AND PROVIDING FOR A NEW CHAPTER 38B

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Chapter 38B of the Township Code entitled "Certificates of Occupancy" is hereby repealed in its entirety.

**SECTION 2.** New Chapter 38B entitled "Letters of No-Interest for Resale of Single Family Dwellings or Individual Units of a Multi-Family Dwelling" is hereby established.

**SECTION 3**. New Section 38B shall read as follows:

The Township, upon request, will issue a "Letter of Non – Interest" with regard to the sale and transfer of title of any single family dwelling or individual unit of a multi-family dwelling, thereby confirming that no new certificate of occupancy is needed or required by the Township for resale of single family dwellings or single units in multi-family dwellings.

**SECTION 4**. The fee charged by the Township to provide a Letter of Non-Interest will be Fifty Dollars (\$50.00) and shall be payable upon request.

**SECTION 5.** Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.
