**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
ACCEPTING AND AUTHORIZING EXECUTION OF A SIDE
BAR AGREEMENT WITH THE TEAMSTERS LOCAL #35,
PUBLIC WORKS EMPLOYEES**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has undertaken negotiations with the Teamsters Local #35, Public Works Employees (the "Union") with regard to a Side Bar Agreement to the current Collective Bargaining Agreement (CBA); and

WHEREAS, the Township and the Union recognize the need to save taxpayer dollars and therefore each have agreed to certain concessions in order to maintain an adequate workforce, provide the Township residents the services they have come to expect and deserve, and furthermore to reduce Township taxpayer expenditures in order to minimize adverse impact to the Township taxpayers; and

WHEREAS, the extended negotiations by and between the Township and the Union have resulted in a Side Bar Agreement which has been prepared and accepted by both sides, a true copy of which is on file at the office of the Township Clerk and can be reviewed by the public during normal business hours:
