## RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, DENYING THE RELEASE OF A MAINTENANCE BOND FOR CONCRETE IMPROVEMENTS FOR FOUR SEASONS AT MIRAGE, SECTION 8

**WHEREAS**, K. Hovnanian, the developer of Four Seasons at Mirage, Section 8 has requested a release of the Maintenance Bond for Concrete Improvements; and

**WHEREAS**, the Township Engineer has inspected subject site, and recommends denying the release of the Maintenance Bond for Concrete Improvements until the Punch List listed below is completed;

- 1. Replace broken Belgian block curb between 11 & 15 Stillwater Court
- 2. Replace broken 4' X 4' concrete sidewalk slab at 4 Aqua View Lane
- 3. Replace broken 4' X 4' concrete sidewalk slab at 12 Aqua View Lane
- 4. Replace broken 4' X 4' concrete sidewalk slab between 29 & 31 Aqua View Lane
- 5. Replace broken 4' X 4' concrete sidewalk slab at 30 Aqua View Lane
- 6. Replace broken 4' X 4' sidewalk slab at 138 Mirage Blvd
- 7. Replace broken 4' X 4' concrete sidewalk slab between 17 \* 18 Turtle Creek Run
- 8. Replace broken 4' X 4' concrete sidewalk slab at 28 Turtle Creek Run
- 9. Replace three (3) settled concrete sidewalk slabs between 12 & 14 Turtle Creek Run
- 10. Replace settled 4' X 4' concrete sidewalk slab at 18 Turtle Creek Run
- 11. Replace settled 4' X 4' concrete sidewalk slab between 18 & 20 Turtle Creek Run
- 12. Replace broken 3' X 12' concrete driveway apron at 14 Turtle Creek Run
- 13. Parge two (2) curb joints at 4 Aqua View Lane
- 14. Parge three (3) curb joints at driveway apron of 6 Aqua View Lane
- 15. Parge curb joints at handicap ramp in front of 6 Aqua View Lane
- 16. Parge curb joint at 10 Aqua View Lane
- 17. Parge three (3) curb joints at the corner of 144 Mirage Blvd
- 18. Parge eight (8) curb joints at driveway apron at 148 Mirage Blvd
- 19. Parge curb joint between inlet and Belgian block curb at 152 Mirage Blvd
- 20. Parge two (2) curb joints in front of hydrant at 156 Mirage Blvd
- 21. Parge 10 (10) curb joints at driveway apron at 3 Rapids Court

**THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey that the request for release of the Maintenance for Four Seasons at Mirage, Section 8 Concrete Improvements is hereby denied based on the recommendation of the Township Engineer, in his letter dated August 15, 2011.
