

## **Resolution 2012-177**

### **RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO EXECUTE A CONTRACT UNDER NEW JERSEY HP WSCA NASPO STATE CONTRACT NUMBER B27164 70262 FOR THE PURCHASE OF SERVERS AND RELATED EQUIPMENT FOR BARNEGAT TOWNSHIP TOWN HALL AND BARNEGAT TOWNSHIP POLICE DEPARTMENT**

**WHEREAS**, the Township of Barnegat adopted Bond Ordinance number 2011-21 on December 30, 2011, which authorized and allocated \$50,000 for the acquisition of information technology equipment to support the Township technology infrastructure, and

**WHEREAS**, under N.J.S.A. 40A:11-12, a municipality may, without advertising for bids, purchase materials, supplies or equipment under a contract entered into on behalf of the state by the Division of Purchase and Property in the Department of Treasury, State of New Jersey, and

**WHEREAS**, there will be substantial savings by the municipality by purchasing under State Contract and utilizing State Contract is in the best interest of the Township of Barnegat, and

**WHEREAS**, the Township Administrator has determined the acquisition of information technology equipment is needed to update outdated equipment for the Township, and

**WHEREAS**, the municipality seeks to purchase this equipment under State Contract number B27164 70262 from the following authorized dealer/vendor:

**WHEREAS**, the attached quote number CLLN146 for technology equipment for Town Hall in the amount of \$13,876.50 dated February 28, 2012 and quote number CPGF120 for the Barnegat Township Police Department in the amount

of \$14,341.50 dated March 1, 2012, describes the information technology equipment being purchased under State Contract, and
