RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, RESCINDING THE ADDITIONAL FIFTY DOLLAR CHARGE FOR INSPECTION OF PROPERTIES IN THE BARNEGAT TOWNSHIP HISTORIC DISTRICT

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has considered the additional fifty dollar (\$50.00) inspection fee charge for homes and properties within the Township's Historic District); and

WHEREAS, the Township believes that the additional fifty dollar (\$50.00) charge is unnecessary, and a burden to homeowners and property owners within the Township's Historic District who are attempting to preserve the historic nature of their property:

NOW, THEREFORE, BE IT RESOLVED, this 19th day of March, 2012, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township rescinds and declares null and void the additional fifty dollar (\$50.00) charge previously imposed on homeowners and property owners for inspections within the Township's Historic District.

2. The Township authorizes and directs the Mayor, Township Administrator, and Township Clerk to execute any and all necessary documents in order to implement the intent of this Resolution.
