RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO EXECUTE A CONTRACT UNDER NEW JERSEY STATE CONTRACT NUMBER A80948 FOR THE PURCHASE OF VARIOUS FIREFIGHTER PROTECTIVE CLOTHING AND EQUIPMENT FOR THE BARNEGAT VOLUNTEER FIRE COMPANY.

WHEREAS, the Township of Barnegat adopted Bond Ordinance number 2011-21 on December 30, 2011, which authorized and allocated \$300,000 for the acquisition of Law Enforcement vehicles and equipment, and

WHEREAS, under N.J.S.A. 40A:11-12, a municipality may, without advertising for bids, purchase materials, supplies or equipment under a contract entered into on behalf of the state by the Division of Purchase and Property in the Department of Treasury, State of New Jersey, and

WHEREAS, there will be substantial savings by the municipality by purchasing under State Contract and utilizing State Contract is in the best interest of the Township of Barnegat, and

WHEREAS, the Township Administrator has determined the acquisition of various firefighter protective clothing and equipment is needed in order to maintain an effective and safe delivery of volunteer firefighting services to the Barnegat community, and

WHEREAS, the municipality seeks to purchase this protective clothing under State Contract number A80948 from the following authorized dealer/vendor:

WHEREAS, the Township wishes to purchase protective clothing and equipment, for a total cost not to exceed \$27,715.09, and

WHEREAS, the attached quote , dated April 6, 2012, describes the firefighter protective clothing, gear and equipment being purchased under State Contract, and

NOW, BE IT RESOLVED, this 7th day of May, 2012 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, of the following:

1. The Township authorizes the issuance of required purchase order(s) charged to the appropriate accounts needed to acquire said firefighter protective clothing, gear and equipment.
2. The Township authorizes and directs the Mayor, Township Clerk, Chief Financial Officer and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
