

RESOLUTION 2012-315

Resolution of the Township of Barnegat, County of Ocean, State of New Jersey, to execute a contract under New Jersey State Contract Number 09-X-20248 for the purchase of replacement body for truck #24

WHEREAS, the Township of Barnegat adopted Bond Ordinance number 201121 on December 30, 2011, which authorized and allocated \$200,000 for the acquisition of Public Works vehicles and equipment, and

WHEREAS, under N.J.S.A. 40A:11-12, a municipality may, without advertising for bids, purchase materials, supplies or equipment under a contract entered into on behalf of the state by the Division of Purchase and Property in the Department of Treasury, State of New Jersey, and

WHEREAS, there will be substantial savings by the municipality by purchasing under State Contract and utilizing State Contract is in the best interest of the Township of Barnegat, and

WHEREAS, the Township Administrator has determined the acquisition of these vehicles are needed in order to maintain an effective and efficient delivery of municipal services to the Barnegat community, and

WHEREAS, the municipality seeks to purchase this equipment under State Contract number X09-X-20248 from the following vendor:

WHEREAS, the Township wishes to purchase a replacement body for Truck #24 (mini-dump) for a total cost not to exceed \$6,200., and

WHEREAS, the attached schedule describes the vehicles and related options being purchased under State Contract, and

NOW, BE IT RESOLVED, this fourth day of June, 2012 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, of the following:

1. The Township authorizes the issuance of required purchase orders charged to the appropriate accounts needed to acquire said Public Works vehicles.
