**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, REAPPOINTING SHARON L. AUER AS ACTING MUNICIPAL CLERK IN THE TOWNSHIP OF BARNEGAT, PURSUANT TO AND IN ACCORDANCE WITH N.J.S.A. 40A:9-1333**

1. Sharon L. Auer be reappointed as Acting Municipal Clerk in the Township of Barnegat for a one (1) year term, commencing on June 27, 2012 through June 27, 2013, pursuant to and in accordance with *N.J.S.A. 40A:9-133*.

2. This Resolution is effective on June 27, 2012.

3. The annual salary for the Acting Municipal Clerk shall be \$68,831.64, effective June 27, 2012.

4. The Township authorizes and directs the Mayor, Township Clerk, and Township Administrator to execute any and all necessary documents in order to implement the intent of this Resolution.
