

**RESOLUTION NO. 2012-325**

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, URGING THE STATE OF NEW JERSEY AND THE NEW JERSEY DEPARTMENT OF TRANSPORTATION TO INSTALL A WORKING TRAFFIC LIGHT AT THE INTERSECTION OF NEW JERSEY STATE HIGHWAY ROUTE 72 AND ROUTE 532**

**WHEREAS**, the Township Committee of the Township of Barnegat, Ocean of County, State of New Jersey (the “Township”) is concerned about the increased number of accidents in and around the intersection of New Jersey State Highway 72 and Route 532; and

**WHEREAS**, the surrounding area of that intersection is populated with senior citizens who, along with others, have difficulty with the substantial increase in traffic, especially during the summer season; and

**WHEREAS**, that intersection has been the subject of numerous motor vehicle accidents, including fatalities; and

**WHEREAS**, the Township is concerned as to the increased traffic generated by the summer tourist season, as well as the fact that the increased population in and around Barnegat Township and Stafford Township has adversely impacted upon this intersection, from a traffic standpoint:

**NOW, THEREFORE, BE IT RESOLVED**, this 4th day of June, 2012, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township urges the New Jersey Department of Transportation to install a working traffic light at the intersection of New Jersey State Highway 72 and Route 532 as quickly as possible.
