

**RESOLUTION 2013-32**

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN, STATE OF NEW JERSEY  
APPOINTING CONFLICT TOWNSHIP ATTORNEY FOR THE YEAR 2013**

**WHEREAS**, Public Law 2004, Chapter 19 was signed by the Governor and takes effect on January 1, 2006, and

**WHEREAS**, Ordinance 2005-03, Ordinance 2005-04, and Ordinance 2005-05 were adopted by the Barnegat Township Committee on February 22, 2005, set forth the requirements and procedures for the receipt of proposals for Professional Services Contracts, and

**WHEREAS**, proposals for Professional Services Contracts were received and reviewed by the Township Committee in an open and fair process in accordance with Ordinance 2005-03, Ordinance 2005-04 and Ordinance 2005-05 and public law, and

**WHEREAS**, the position of Conflict Township Attorney is vacant as of January 1st, 2013, and

**WHEREAS**, pursuant to N.J.S.A. 4DA:9-139 and Barnegat Code section 2-1, a Conflict Township Attorney is to be appointed by the Township Committee for a one-year term; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 4DA-11-1, ET SEQ.) requires that notice of a resolution authorizing the award of contracts for "PROFESSIONAL SERVICES" without competitive bids be publicly advertised; and

**WHEREAS**, the maximum amount of this contract is undetermined, the Township Certified Finance Officer has certified that funds are available for this purpose in an appropriation in the 2013 Temporary Budget, per attached certification, now

**THEREFORE BE IT RESOLVED** by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. Ben Montenegro and the firm of Montenegro, Thompson, Montenegro & Genz along with the firm of Rothstein, Mandell, Strohm & Halm are hereby appointed to the position of Conflict Township Attorney of the Township of Barnegat for a period beginning on the first day of January 2013 and ending December 31st, 2013. Said appointee shall be paid on a fee basis.
2. This appointment is made without competitive bidding for "Professional Services" to be performed by a person authorized by Law to practice a recognized profession.
3. This appointment shall be formally reviewed by the Township Committee for 2013 procedures, professional policies and guidelines within 60 days.

4. A notice of this appointment shall be advertised in a newspaper of general circulation within the boundaries of the Township of Barnegat not more than (10) days after the passage of this resolution.
  
5. That the Mayor is authorized to execute and the Clerk to attest to a "Professional Services" contract with: Ben Montenegro and the firm of Montenegro, Thompson, Montenegro & Genz, 501 Burnt Tavern Road, Brick, NJ 08724 along with the firm of Rothstein, Mandell, Strohm & Halm, 150 Airport Road, Suite 600, PO Box 3017, Lakewood, NJ 08701 in connection with the services aforesaid.
