

**RESOLUTION 2013-320**

**A RESOLUTION AUTHORIZING DISPOSAL OF  
SURPLUS PROPERTY OF THE TOWNSHIP OF OCEAN,  
COUNTY OF OCEAN, STATE OF NEW JERSEY**

- (3) The sale is being conducted pursuant to Local Finance Notice 2008-9.
