

ORDINANCE NO. 2012 -11

**ORDINANCE OF THE COMMITTEE OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY
AMENDING AND SUPPLEMENTING CHAPTER 55 OF THE
BARNEGAT TOWNSHIP CODE ENTITLED "LAND USE"**

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of Barnegat Township, Ocean County, and State of New Jersey, as follows:

SECTION 1. Chapter 55 of the Township Code, in particular Section 55-181.1C(9) is hereby amended to read as follows:

A. Political Signs. Political signs shall be located on private property set back so as to not interfere with the site triangle at intersections or driveways and in no other way interfere with pedestrian or vehicular vision and safety. No such sign shall exceed four (4) square feet in area. Signs shall be permitted in all Zoning Districts within forty-five (45) days prior to any election and shall be removed within seven (7) days after the election. Political signs do not require a permit.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
