**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY
AMENDING PART II OF THE CODIFIED ORDINANCES
OF THE TOWNSHIP OF BARNEGAT ENTITLED "GENERAL
LEGISLATION" TO AMEND SECTION 70E ENTITLED
"CONTAINERIZED YARD WASTE"**

BE IT ORDAINED BY the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

SECTION 2. Definitions:

Section 2d. Yard Waste shall be deleted in its entirety and replaced with the following.

Section 2d. Yard Waste – means brush clippings, garden clippings, acorns and ornamental grass.

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AMENDING PART II OF THE CODIFIED ORDINANCES OF
THE TOWNSHIP OF BARNEGAT ENTITLED "GENERAL
LEGISLATION" TO INCLUDE A NEW SECTION 70E
ENTITLED "CONTAINERIZED YARD WASTE"

BE IT ORDAINED BY the Township Committee of the Township of
Barnegat, County of Ocean, State of New Jersey, as follows:

SECTION 1. Purpose: An ordinance to establish requirements for the
proper handling of yard waste in the Township of Barnegat, so as to protect
public health, safety and welfare, and to prescribe penalties for the failure to
comply.

SECTION 2. Definitions: For the purpose of this ordinance, the
following terms, phrases, words and their derivations shall have the
meanings stated herein unless their use in the text of this Section clearly
demonstrates a different meaning. When not inconsistent with the context,
words used in the present tense include the future, words used in the plural
number include the singular number, and words used in the singular
number include the plural number. The word "shall" is always mandatory
and not merely directory.

- a. Containerized - means the placement of yard waste in a trash
can, bucket, bag or other vessel, such as to prevent the yard
waste from spilling or blowing out into the street and coming
into contact with stormwater.
- b. Person - any individual, corporation, company, partnership,
firm, association, or political subdivision of this State subject to
municipal jurisdiction.
- c. Street - means any street, avenue, boulevard, road, parkway,
viaduct, drive, or other way, which is an existing State, county,
or municipal roadway, and includes the land between the street
lines, whether improved or unimproved, and may comprise
pavement, shoulders, gutters, curbs, sidewalks, parking areas,
and other areas within the street lines.
- d. Yard Waste - means leaves.

SECTION 3. Prohibited Conduct: The owner or occupant of any property, or any employee or contractor of such owner or occupant engaged to provide lawn care or landscaping services, shall not sweep, rake, blow or otherwise place yard waste, unless the yard waste is containerized, in the street. If yard waste that is not containerized is placed in the street, the party responsible for placement of yard waste must remove the yard waste from the street or said party shall be deemed in violation of this ordinance.

SECTION 4. Enforcement: The provisions of this Section shall be enforced by the Police Department and the Board of Health of the Township of Barnegat.

SECTION 5. Violations and Penalties: Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed One Hundred Fifty Dollars (\$150.00).

SECTION 6. Repealer: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.


SECTION 7. Severability: If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 8. Effective Date: This ordinance takes effect after second reading and publication as required by law.

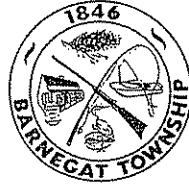
