ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY CANCELLING CERTAIN APPROPRIATION BALANCES HERETOFORE UNFUNDED PROVIDED FOR VARIOUS GENERAL CAPITAL PROJECTS REAPPROPRIATING SUCH TOTALING \$85,000.00 AND APPROPRIATION **BALANCES** FOR VARIOUS UNFUNDED **IMPROVMENTS** AND TO CAPITAL GENERAL REAPPROPRIATE THE SUM OF \$85,000.00 TO PAY THE COST THEREOF

BE IT ORDAINED by the Township Committee of Barnegat, County of Ocean, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

SECTION 1. The following unfunded appropriations remaining as a balance in the bond ordinance heretofore adopted by the Township of Barnegat, County of Ocean, New Jersey ("Township") are hereby cancelled:

Ordinance #11-21 \$85,000.00

SECTION 2. The aggregate sum of \$85,000.00 is hereby reappropriated from the bond ordinance referred to in Section 1. The elements of the ordinance are described below:

Police Vehicle Equipment

Cost necessary for the acquisition and installation of a law enforcement grade mobile video system for the Barnegat Township Police Department. Includes, but is not limited to the purchase of all hardware, software, equipment, material, supplies and installation work necessary to place the video system into proper service.

Amount of Appropriation -- \$85,000.00

SECTION 3. The period of usefulness of said purpose, within the limitation of the Local Bond Law and according to the reasonable life thereof computed from the date of said bonds authorized by this ordinance, is not less than five (5) years.

SECTION 4. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extend of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the clerk and available for inspection.

SECTION 5. The improvements authorized are not current expenses and are general improvements that the Township may lawfully make. No part of the cost of the improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

SECTION 6. This ordinance shall take effect twenty (20) days following the first publication thereof after final passage, as provided by the Local Bond Law.
