

ORDINANCE NO. 2012 - 28

**ORDINANCE OF THE COMMITTEE OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY
SUPPLEMENTING CHAPTER 74 OF THE BARNEGAT TOWNSHIP
CODE ENTITLED "WATER/SEWER UTILITY" ADDING ARTICLE
IX ENTITLED "EXEMPTIONS FROM WATER/SEWER UTILITY
FEES"**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, believes it appropriate that Chapter 74 of the Codified Ordinances of the Township of Barnegat, County of Ocean, State of New Jersey, be modified and amended;

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey wishes to exempt certain public service departments from water and sewer fees;

THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey, as follows:

SECTION 1: Chapter 74 of the Codified Ordinances of the Township of Barnegat ("Water/Sewer Utility") is hereby amended and expanded to include Article VIX entitled "Exemptions from Water/Sewer Utility Fees".

SECTION 2: The Township of Barnegat recognizes the extraordinary public service provided by the following organizations and in recognition of these organizations service to the citizens of the Township of Barnegat, the following are hereby exempt from water and sewer utility fees:

A. The Barnegat Township First Aid Squad headquarters located at 6 Birdsall Street, Barnegat, New Jersey, and otherwise known as Block 251, Lot 2 on the Tax Map of the Township of Barnegat.

B. The Barnegat Township Volunteer Fire Company #1 headquarters located at 9 Birdsall Street, Barnegat, New Jersey, Block 250, Lot 19 on the Tax Map of the Township of Barnegat.

C. The Barnegat Township Fire Company substation located at 499 Barnegat Boulevard, Barnegat, New Jersey, Block 116.01, Lot 2.02 on the Tax Map of the Township of Barnegat.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.
