RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, CONSENTING TO UNION PLAZA CONNECTING TO OCEAN TOWNSHIP WATER SUPPLY

WHEREAS, the owner of Block 146.01, Lot 6.01 also known as 575 North Main Street, Barnegat, New Jersey desires to connect said property to a water supply system; and

WHEREAS, said Block 146.01, Lot 6.01 is within the Barnegat Township Water and Sewer Utility Service Area; and

WHEREAS, at the present time, Barnegat Township has no immediate intentions of supplying water system facilities to said Block 146.01, Lot 6.01; and

WHEREAS, the Ocean Township Municipal Utilities Authority has a water supply system near said Block 146.01, Lot 6.01; and

WHEREAS, said Block 146.01, Lot 6.01 known as "Union Plaza" on Union Boulevard and Route 9 desires to connect to the Ocean Township Municipal Utilities Authority System by the extension of a water line down and across from Route 9 in order to connect to the existing system of the Ocean Township MUA on Bayshore Drive; and

WHEREAS, said proposed connection to the Ocean Township MUA System would allow said water supply system to services Block 146.01, Lot 6.01.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:

1. Robert Taff and Silvia Sylvi, whose address is 143 Route 70, Toms River, NJ and who is the owners of Block 146.01, Lot 6.01 is hereby authorized to connect to the Ocean Township Municipal Authority's Water Supply System as described in the preamble hereof. That Robert Taff and Silvia Sylvi shall be responsible to obtain any and all permits in connection with said extension and to absorb the costs thereof.
2. That Robert Taff and Silvia Sylvi shall be responsible to pay any and all connection and service fees to the OTMUA in accordance with said Authority's requirements and billing procedures.
3. That Robert Taff and Silvia Sylvi or their successors in right, title and interest shall continue to remain as a customer of the OTMUA in accordance with said Authority's policies and procedures. However, if the Township of Barnegat at some time extends water system supply facilities to the properties referenced herein, then, upon sixty (60) days of notice of availability, Robert Taff and Silvia Sylvi shall disconnect from the OTMUA and connect into the Barnegat Water System Facilities. At that time, Robert Taff and Silvia Sylvi shall be

- responsible to pay to Barnegat Township all normal required connection and services charges.
4. This Agreement is specifically contingent upon the adoption of a resolution by the Ocean Township Municipal Utilities Authority authorizing the water service hereinabove referenced to and in accordance with the general terms and conditions of this resolution.
