RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING CHIEF RAYMOND HAYDUCKA AS HEARING OFFICER FOR THE TOWNSHIP

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has been advised of the need to hire a Hearing Officer to entertain and conduct hearings of employees of the Township affected by disciplinary charges; and

WHEREAS, Chief Raymond Hayducka, Chief of Police of South Brunswick, New Jersey, has indicated a willingness to serve as Township Hearing Officer, and has provided sufficient credentials to confirm that he will be able to handle this task; and

WHEREAS, this is a professional appointment and, therefore, exempt from the normal bidding requirements set forth in the New Jersey Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Township does not believe that payment for the services will exceed \$17,000.00 annually and, therefore, the need for this request for professional service (RFP) is not required.

NOW, THEREFORE, BE IT RESOLVED, this 20th day of August 2012, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. Chief Raymond Hayducka is hereby appointed as Hearing Officer for the Township of Barnegat.
