



Hi Sharon. As you know, construction is in progress on the sanitary sewer mains and pumping station in Hillside Avenue. We anticipate that the sanitary sewer installation will be completed by the end of December barring any unforeseen circumstances.

As you know, the Township has been awarded a municipal aid grant to for the repaving of Hillside Avenue. This work will be performed in the spring after the sewer trench has been allowed to settle for several months. We have been advised by the NJDOT that the plans for the subject project are approved and the Township is authorized to advertise for bids.
