**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AWARDING THE CONTRACT FOR VARIOUS
SANITARY SEWER REPAIRS**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for various sanitary sewer repairs; and

WHEREAS, the bids have been solicited by the Township in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, two (2) bids have been received in response to the bid solicitation from Video Pipe Services, Inc., in the amount of \$246,120.00, Mathis Construction Co., Inc., in the amount of \$249,912.00 and Montana Construction Corp., in the amount of \$369,075.00; and

WHEREAS, the bid documentation submitted by the lowest responsible bidder, Video Pipe Services, Inc., Newfield, NJ, has been reviewed by the Township's professional staff and found to be acceptable and in full compliance with the bid specifications; and

WHEREAS, the bid received from the lowest responsible bidder, Video Pipe Services, Inc., is in compliance with the Township's budgetary constraints; now

THEREFORE, BE IT RESOLVED, this 19th day of August, 2013 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of its professional staff and awards the bid for the project to the lowest responsible bidder, Video Pipe Services, Inc., in the amount of \$246,120.00
2. The Township authorizes and directs the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
