

**RESOLUTION 2013-347**

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AWARDING THE CONTRACT A REAR LOADING  
DESIGN REFUSE COLLECTION TRUCK BODY**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for a Rear Loading Design Refuse Collection Truck Body; and

**WHEREAS**, the bids have been solicited by the Township in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, one (1) bid has been received in response to the bid solicitation from GranTurk Equipment Co., Inc.; and

**WHEREAS**, the bid documentation submitted by the sole responsible bidder, GranTurk Equipment Co., Inc., Baltimore, MD, has been reviewed by the Township's professional staff and found to be acceptable and in full compliance with the bid specifications; and

**WHEREAS**, the bid received from the lowest responsible bidder, GranTurk Equipment Co, Inc., is in compliance with the Township's budgetary constraints; now

**THEREFORE, BE IT RESOLVED**, this 19<sup>th</sup> day of August, 2013 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of its professional staff and awards the bid for the project to the sole responsible bidder, GranTurk Equipment Co., Inc., in the amount of \$89,817.00
2. The Township authorizes and directs the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
