- 1. The Township of Barnegat hereby renews its membership in the Ocean County Municipal Joint Insurance Fund for a three (3) year period, beginning January 1, 2014 and ending December 31, 2016.
- 2. The Township of Barnegat hereby ratifies and reaffirms the Indemnity and Trust Agreement, Bylaws and other organizational and operational documents of the Ocean County Municipal Joint Insurance Fund as from time to time amended and altered by the Department of Insurance in accordance with the Applicable Statutes and administrative regulations as if each and every one of said documents were re-executed contemporaneously herewith.
- 3. The Township of Barnegat agrees to be a participating member of the Fund for the period herein provided for an to comply with all of the rules and regulations and obligations associated with said membership.
- 4. In consideration of the continuing membership of the Township of Barnegat in the Ocean County Municipal Joint Insurance Fund agrees, subject to the continuing approval of the Commissioner of Insurance, to accept the renewal application of the Township of Barnegat.
- 5. Executed the 16th day of September, 2013 as the lawful and binding act and deed of the Township of Barnegat, which execution has been duly authorized by public vote of the governing body.
