

RESOLUTION 2013-398

RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING THE CONTRACT A NEW EMERGENCY MEDICAL VEHICLE

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for a new Emergency Medical Vehicle; and

WHEREAS, the bids have been solicited by the Township in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, one (1) bid has been received in response to the bid solicitation from Bay Head Investments Inc.; and

WHEREAS, the bid documentation submitted by the sole responsible bidder, Bay Head Investments, Inc., 43 Jefferson Avenue, Berlin, NJ 08009, has been reviewed by the Township's professional staff and found to be acceptable and in full compliance with the bid specifications; and

WHEREAS, the bid received from the sole responsible bidder, Bay Head Investments, Inc., is in compliance with the Township's budgetary constraints; now

THEREFORE, BE IT RESOLVED, this 7th day of October, 2013 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township accepts the recommendations of its professional staff and awards the bid for the project to the sole responsible bidder, Bay Head Investments, Inc., in the amount of \$183,463.20
2. The Township authorizes and directs the Mayor, Township Clerk and Township Administrator to execute any and all necessary documents in order to implement the intent of this resolution.
