**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AUTHORIZING THE MAYOR TO SIGN AN  
AGREEMENT FOR THE MUNICIPAL ALLIANCE GRANT  
FOR THE YEAR 2013/2014**

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey; and

WHEREAS, Ocean County Board of Health, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and

WHEREAS, the Ocean County Board of Health Department has administered the Municipal Alliance grant for January 1, 2013 through December 31, 2013 grant term; and

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has extended the 2013 grant term until June 30, 2014, in order to transition the grant to the State fiscal year rather than the calendar year cycle; and

WHEREAS, funding has been made available to the Ocean County Health Department and Municipal Alliances in the amount of 50% of its approved 2013 grant total for the six-month extension period of January 1, 2014 to June 30, 2014, contingent upon meeting the 25% Cash Match and 75% In-Kind Match grant requirement for the extension funding.

NOW, THEREFORE BE IT RESOLVED, that the Township of Barnegat Committee does hereby authorize the submission of the grant extension for the Barnegat Township Municipal Alliance grant in the amount of:
