NOTICE IS HEREBY GIVEN that the Township Committee of the Township of Barnegat, in the County of Ocean, will on August 25, 2021 at 10:00 a.m., at the Ocean Township Clerk's Office, Municipal Building, 50 Railroad Avenue, Ocean, New Jersey 08758, or as soon thereafter as the matter may be reached, receive **sealed bids** for:

DETAILED SPECIFICATIONS are on file and available at the Township Clerk's Office, Municipal Building, 900 West Bay Avenue, Barnegat, New Jersey, 08005, and may be obtained or inspected by prospective bidders during normal business hours. Bidders will also be furnished with a copy of the Specifications upon proper notice of the Township Clerk. Each bidder will be required to provide and submit to the Township the following: **Each bid must be accompanied by all the requirements as more fully set forth in the Bid Specifications.**

Each bidder shall:

- a. Submit the bid, signed in Standard Proposal forms in the manner designated therein and as required by specifications; as well as other forms provided in the Packet of the Bid Specifications must be signed in the manner designated therein.
- b. Provide proof of the required insurances as per the specifications.
- c. Each bid must be accompanied by a Bid Bond or a certified check payable to the Township of Barnegat, for not less than ten (10) percent of the amount of the bid, not to exceed \$20,000.00; a Non-Collusion Affidavit; and a Certificate of Ownership and a Business Registration Certificate.
- d. Bidders are required to comply with the requirements of P.L. 1975, c.127 (N.J.A.C. 17-17).
- e. Each bid shall be addressed to Donna M. Manno, RMC, Township Clerk, Township of Barnegat, 900 West Bay Avenue, Barnegat, New Jersey, 08005, and shall be delivered either in person, by mail or delivery at or before the time for the receipt of bids. The Township Clerk shall not be responsible for any bid which is not delivered or received prior to the time set for the receipt of same. Each bidder shall be charged \$25.00 for the purchase of the Bid Specifications, payable to the Township of Barnegat.
- f. Each bid shall be contained in a sealed envelope or wrapper addressed to the Township Clerk and shall have a statement written on the face of said envelope citing that it is a bid so that it will not be inadvertently opened.
- g. The Township of Barnegat reserves the right to accept or reject any or all bids as it is in the best interest of the Township.
