**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A SHARED
SERVICES AGREEMENT WITH OCEAN TOWNSHIP, STATE OF NEW
JERSEY, FOR DISASTER RELATED SERVICES FOR
SUPERSTORM SANDY (FEMA Disaster #4086)**

WHEREAS, Hurricane Sandy was an extraordinary event which caused considerable property damage and significant interruption of daily activities for many residents of both the Townships of Barnegat and Ocean, and

WHEREAS, the Township of Barnegat has agreed to provide to Ocean Township requested resources and assets for disaster related services for Hurricane Sandy (FEMA Disaster #4086), and

WHEREAS, the State of New Jersey has strongly encouraged municipalities to participate in shared service agreements in order to achieve financial and operational benefits and both the Townships of Barnegat and Ocean have executed many meaningful shared service agreements that are beneficial to both communities, and

WHEREAS, by having numerous far reaching shared service agreements in place, both towns have been able to establish a strong working relationship that has been beneficial to both communities, and

WHEREAS, during times of crisis, both Barnegat and Ocean Townships incorporate a joint approach to emergency management in order to realize an effective response to storm conditions, and

WHEREAS, for purposes of maximizing Federal Emergency Management Agency (FEMA) reimbursement for storm related expenditures, FEMA recommends that the governing bodies of public entities sharing resources take necessary formal action to acknowledge the sharing of assets during emergency situations, and


WHEREAS, as a result of a proven track record of success between the two (2) communities in sharing services, the Township Committee of the Township of Barnegat authorizes the sharing of resources and assets with the Township of Ocean for Hurricane Sandy work, and

NOW THEREFORE, BE IT RESOLVED, by the Governing Body of the Township of Barnegat, County of Ocean, State of New Jersey, authorizes and approves the sharing of assets and resources with the Township of Ocean required to address and handle Hurricane Sandy work along with the following:

1. The Township authorizes and directs the Mayor, Township Administrator, Township Clerk and other appropriate officials to share with the Township of Ocean any needed resources or assets required for Hurricane Sandy related work.
2. The Township authorizes and directs the Mayor, Township Administrator and Township Clerk to execute any additional documents needed in order to implement the intent of this resolution.
3. The Township authorizes the Township Administrator to take the required action to institute the intent of this resolution and to incorporate the desired benefits of the resolution into the daily operations of the Township.
