**Whereas**, the County of Ocean has two (2) buses that they will sell to the Township of Barnegat for \$1.00 each; now


**Therefore be it resolved** by the Township of Barnegat Committee that they are interested in purchasing the following buses from the County of Ocean at a cost of \$1.00 each;
