

**RESOLUTION NO. 2014-083**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE PURCHASE OF TWO POLICE MOTORCYCLES FROM THE TOWNSHIP OF STAFFORD.**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has been advised by representatives of the Township of Stafford (“Stafford”) of the availability of two (2) police motorcycles which Stafford wishes to sell; and

**WHEREAS**, the two (2) motorcycles are 2006 units, each with less than 15,000 miles. The purchase price of \$11,000.00 (total) would include all emergency lighting and free training on the law enforcement use of the motorcycles; and

**WHEREAS**, the Township believes this is an attractive offer and wishes to purchase the vehicles from Stafford under the aforementioned terms and conditions.

**NOW, THEREFORE, BE IT RESOLVED**, this 18<sup>th</sup> day of February, 2014, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township authorizes the purchase of two (2) 2006 police motorcycles from the Township of Stafford for a total cost of \$11,000.00. This purchase price will include all emergency lighting and free training on the law enforcement use of the motorcycles.

2. The Township authorizes and directs the Mayor, Township Clerk, Township Administrator and Township CFO to execute any and all necessary documents in order to implement the intent of this Resolution.
