

**RESOLUTION NO. 2014-105**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE  
TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF  
NEW JERSEY, ACCEPTING AND APPROVING THE  
COLLECTIVE BARGAINING AGREEMENT WITH THE  
EMPLOYEES OF THE WATER AND DEPARTMENT**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has been discussing with representatives of the Teamsters Local #35, on behalf of the Blue Collar Employees, a/k/a the Employees in the Township Sewer and Water Department (hereinafter referred to as the “Union”); and

**WHEREAS**, the result of the ongoing negotiations is that the parties have conceptually approved and agreed to a four (4) year agreement beginning January 1, 2013 through December 31, 2017; and

**WHEREAS**, a copy of the proposed Agreement is on file at the office of the Township Clerk and can be reviewed during normal business hours; and

**WHEREAS**, the Township finds that the proposed Agreement is acceptable and in the long term best interests of the Township, its employees and the taxpayers of Barnegat Township.

**NOW, THEREFORE, BE IT RESOLVED**, this 18<sup>th</sup> day of February, 2014, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts and approves the aforementioned Collective Bargaining Agreement, a true copy of which is on file at the office of the Township Clerk and can be reviewed during normal business hours.
