**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY TO
AUTHORIZE THE AWARD OF A CONTRACT FOR
BARNEGAT BEACH REPLENISHMENT, CONTRACT 2 –
MATERIAL PROCUREMENT**

WHEREAS, the Township advertised for the receipt of bids on May 25, 2014 for the Barnegat Beach Replenishment, Contract 2 – Material Procurement; and

WHEREAS, at the time and place for the receipt of bids, a total of one (1) bid was received for the project; and

WHEREAS, the lowest bid of \$133,522.00 was submitted by Master Wire Manufacturing, Inc, 1019 Black Horse Pike, PO Box 328, Hammonton, NJ 08037; and

WHEREAS, the Township Engineer has reviewed the bid documents submitted by Master Wire Manufacturing, Inc.. and, by letter dated July 15, 2014, has found that the bid appears to be reasonable and is in substantial compliance and has recommended an award of the contract to Master Wire Manufacturing Inc., subject to the review and approval of the Township Attorney; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available for the award of this contract; and

WHEREAS, the Township Attorney has reviewed the bid documents submitted by Master Wire Manufacturing Inc., and has found them to be in substantial compliance; and

WHEREAS, now it is the desire of the Mayor and Township Committee to act upon the recommendation of the Township Engineer and Township Attorney.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. That a contract shall be awarded to Master Wire Manufacturing Inc., 1019 Black Horse Pike P.O. Box 328, Hammonton, New Jersey, as the lowest responsible bidder, for the Barnegat Beach Replenishment, Contract 2 – Material Procurement, in the total amount of \$133,522.00.
2. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer of Barnegat Township, to Adams Rehmann & Heggan, and to Master Wire Manufacturing Inc.
