**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN, STATE OF NEW JERSEY TO
AUTHORIZE THE AWARD OF A CONTRACT FOR
BARNEGAT BEACH REPLENISHMENT, CONTRACT 1 –
SITE WORK**

WHEREAS, the Township advertised for the receipt of bids on May 25, 2014 for the Barnegat Beach Replenishment, Contract 1 – Site Work; and

WHEREAS, at the time and place for the receipt of bids, a total of four (4) bids were received for the project from the following Bidders:

Beacon Marine Construction	\$ 497,000.00
Jamili Developers, LLC	\$ 729,873.00
Albert Marine Construction, Inc.	\$1,013,944.00
Mathis Construction Co., Inc.	\$1,256,032.64

WHEREAS, the lowest bid of \$497,000.00 was submitted by Beacon Marine Construction; and

WHEREAS, the Township Engineer has reviewed the bid documents submitted by Beacon Marine Construction and, by letter dated July 15, 2014, has found that the bid appears to be reasonable and is in substantial compliance and has recommended an award of the contract to Beacon Marine Construction, subject to the review and approval of the Township Attorney; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available for the award of this contract; and

WHEREAS, the Township Attorney has reviewed the bid documents submitted by Beacon Marine Construction, and has found them to be in substantial compliance; and

WHEREAS, now it is the desire of the Mayor and Township Committee to act upon the recommendation of the Township Engineer and Township Attorney.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. That a contract shall be awarded to Beacon Marine Construction, 310 Main Street West Creek New Jersey, as the lowest responsible bidder, for the Barnegat Beach Replenishment, Contract 1 – Site Work, in the total amount of \$497,000.00.

2. That the bids and bid securities for the second, third and fourth lowest bidders be retained and held open pending execution of the Contract Documents by Beacon Marine Construction
3. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer of Barnegat Township, to Adams Rehmann & Heggan, and to Beacon Construction, Inc.
