

## RESOLUTION 2014-462

### RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO EXECUTE A CONTRACT UNDER NEW JERSEY STATE CONTRACT NUMBER A83558 T2101 FOR THE PURCHASE OF A 4X4 TRUCK FOR THE WATER/SEWER UTILITY DEPARTMENT

**WHEREAS**, THE Township of Barnegat adopted Bond Ordinance 2013-08 on June 3, 2013, which authorized and allocated \$40,000.00 for the acquisition of Water/Sewer Utility vehicles and equipment; and

**WHEREAS**, under N.J.S.A. 40A:11-12, a municipality may, without advertising for bids, purchase materials, supplies or equipment under a contract entered into on behalf of the state by the Division of Purchase and Property in the Department of Treasury, State of New Jersey; and

**WHEREAS**, there will be substantial savings by the municipality by purchasing under State Contract, and utilizing State Contract is in the best interest of the Township of Barnegat; and

**WHEREAS**, the Township Administrator has determined the acquisition of these vehicles are needed in order to maintain an effective and efficient delivery of municipal services to the Barnegat Township Community; and

**WHEREAS**, the municipality seeks to purchase this equipment under State Contract numb A83558 T2101 from the following vendor:
